

CANADIAN INTERNATIONAL DRIVING PERMIT APPLICATION FORM

IMPORTANT: International Driving Permits will be issued only to persons 18 years of age or over who hold full valid Canadian provincial driving licences. This excludes provisional or learner's licences, and licences under suspension. The IDP is valid for one year from date of issue and cannot be issued for any category of vehicle which is not at present covered by the Canadian driving licence. The Canadian IDP is not valid in Canada. Attach two signed, full-face passport photographs, and a copy of the front and back of your valid Canadian driver's license with this application. A fee of **\$32 CAD plus shipping charges** is applicable for an IDP. Due to privacy legislation, if your application is sent in by mail, a representative of CAA will telephone or email you to obtain your credit card information once they receive the application for the International Driver's Permit.
